# Council wraps up last meeting of the year

The town council approved the appropriation of \$980,000 for the ongoing lead service water line replacement project at its meeting last week.

"This is going to be our seventh lead line removal project," said public works director Steve Calla. "Every year, we strive to remove 100 services, with just under 500 at this time, so we've made good progress. It is 10-year, zero-interest loans from the MWRA."

Calla said the DEP mandates the town to continue removing the existing lead lines in the town.

"It is something that we have to do; it is certainly very important for public health," said Calla.

In other business during the last meeting of the year, Council President Jim Letterie provided an update on ongoing work at Ingleside Park.

"People are seeing some action at Ingleside Park in terms of the baseball field," said Letterie. "The baseball field that was there is being converted into basically a softball field. It is going to be a dirt infield and it is going to have the ability to multi-task and also still be

used as a baseball field as

"The maintenance should be a little bit easier and it should be used a lot more," Letterie continued. "It is going to be the new home of the Winthrop High School girls softball team, and hopefully, we can get a lot more use out of the recreational space that is down there."

Letterie said residents will also see some work going on at one of the tennis courts at the park. "The success the town

has had with pickleball, it's been incredible with the support that the leagues have had, it just keeps continuing to grow," he said.

The town will be adding two additional pickleball courts to the tennis courts, Letterie said.

In other business, the council heard from Aaron Toffler, the executive director of the Massport Community Advisory Committee (MCAC) and MCAC vice chair and Winthrop representative Jerry Falbo.

The MCAC was created by state legislation in 2014, and comprises 35 communities impacted by Logan Airport and other Massport

# West Bridgewater man arrested on multiple charges in Winthrop

Staff Report

A West Bridgewater man faced a dangerousness hearing Tuesday after being arrested last week in Winthrop with a cache of drugs and a loaded gun in his car, according to Suffolk District Attorney Kevin Hayden.

Dwayne Richardson, 41, was charged in East Boston BMC Friday with trafficking fentanyl over 36 grams, trafficking cocaine 200 grams or more, two counts of drug possession to distribute class B subsequent

offense, drug possession to distribute class C, carrying a firearm without license (4th offense), carrying a loaded firearm without a license, firearm violation with three prior violent/drug related crimes, possession of a firearm felony, and possession of ammunition without an FID card.

Richardson has a previous criminal record including multiple violent and drug related charges dating back to 1992. Most notably, Richardson served 10 years and a day stemming from a conviction in Middlesex Superior Court for illegal possession of a rifle, and two counts of illegal possession of a shotgun, according to the district attorney's office. He was released in 2024.

Judge Steven Kim held Richardson without bail until a dangerousness hearing on Tuesday, December 16.

At about 8:45 on Wednesday, Dec. 10, Winthrop police received BOLO (be on the lookout) for a white 2018 BMW. Earlier that day the owner, later identified as Richardson, had

allegedly brandished a firearm, entered his workplace in Malden and threatened to kill the staff. At around 5:30 the next day Winthrop officers stopped the BMW on Revere Street and arrested Richardson. Officers recovered \$5,090 in cash, a 634.2gram brick of cocaine. 29.7 grams of fentanyl, 8.4 grams of oxycodone, and 3.6 grams of Adderall from the vehicle. A later search of Richardson's person yielded several clear plastic bags of crack-cocaine, fentanyl, and cocaine. Officers also

discovered a Springfield Armory XD5 pistol in the trunk of the BMW, according to the district attorney's office.

"Anytime police can take deadly drugs and illegal guns off the street it's a win

for public safety. The reports of this defendant using a gun to threaten co-workers in the earlier incident adds to the danger posed during this entire episode," Hayden

# Tony Fucillo honored at Gridiron Club Banquet

Winthrop's Tony Fucillo was the recipient of the Dick Lawrence Longevity Award at the Gridiron Club of Boston's Bob Whelan College Night Dinner at the Burlington Marriott.

Fucillo's wife, Carolyn Fucillo, their children, Anthony Fucillo, James Fucillo, and Jenny Fucillo Golic, and his brother, Curry College assistant coach Rich Fucillo, looked on proudly as he accepted the prestigious award.

Also attending were Tony Fucillo's former Winthrop High players and colleagues in the coaching profession.

Fucillo is considered one of the greatest high school football coaches in state history, earning induction in the Massachusetts Football Coaches Association Hall of Fame. Following an outstanding tenure at Winthrop High during which he led the Vikings to the 2006 Super Bowl title, Fucillo continued his career in college as the receivers coach at Tufts University for 12 seasons. He served as an assistant coach on his son Anthony's staff at Belmont

In his remarks, Fucillo said humbly, "It's hard to believe that you can receive an award for doing something that I love doing every single day. This award belongs to the coaches and players that I was lucky enough to

work with at Winthrop High School, Tufts University, and Belmont Hill School."

Fucillo recognized the late Bob DeFelice "for his mentorship during my 15 years at Winthrop High School. He is the reason I started coaching and the reason I stand here tonight."

During his speech, Fucillo graciously asked his wife, Carolyn, to "please stand up" to be recognized by the audience. The crowd responded with warm applause.

"Thank you for your support, your patience and your love," Fucillo said to Mrs. Fucillo. "You have always been my rock, and your belief in me has allowed me to follow my passion. I look forward to the future to celebrating this next chapter with you. Thank you for believing in me and being my best friend."

# Town council thanks outgoing members

The town council honored four outgoing councilors during its last meeting of 2025 last week.

Councilors Joseph Aiello, Rob DeMarco, and Hannah Belcher; as well as former Councilor John Daros were given certificates of appreciation for their service to the town.

DeMarco did not run for reelection this year, while Precinct 5 Councilor Aiello lost a close bid for reelection and Belcher unsuccessfully challenged Jim Letterie for his council president seat. DaRos resigned from office after the election.

During the public speaking portion of the council meeting, several residents thanked the outgoing councilors for their dedication to the town.

Aiello spoke about the accomplishments the council achieved in recent years, from the new climate advisory

council to improved MBTA bus and ferry service to new and improved crosswalks and traffic safety measures.

He also spoke about the future of the town and his hope that everyone would be able to work together.

"Young people on this council and young people in this town really are the force of good change," he said. "There is a lot of great energy coming from the younger people in the community, and I think you've got to get all the voices into this community to make it stronger."

DeMarco said that serving the people of Winthrop was one of the biggest honors of his life.

"I look at everybody here, and I care about everybody," he said. "Nobody comes to this job for fun ... they do it because they genuinely care about the community, and we might have different ways to help the community that we think is best, and a lot of times we will butt heads. But I've always felt a sense of team on this council and that we always got along."

Belcher said that serving the town has been the greatest honor and privilege she's had.

"Especially representing those that I don't agree with, and to the incoming councilors, that is what I've learned the most from," said Belcher. "Those conversations are really special, when you have people, they're over there and I'm over here and we're never going to meet in the middle - there's always a way. It is a challenge, but that's been the most rewarding part."

Letterie said being councilor can be a thankless job, but that nobody gets involved for the thanks.

"I think they get involved to help, and they have different opinions on how best to get to that point," he said. "They do it because they all care about Winthrop."

so it's important to choose and use them safely."

•Buy only listed products. When buying a product that uses a lithium-ion battery, look for a certification mark from an independent testing lab such as UL or Intertek/ ETL. This means the device meets important safety standards.

•Charge devices safely. Always use the cords that came with the product to charge. Follow the instructions from the manufacturer. Buy new chargers from the manufacturer or one that the manufacturer has approved. Charge your device on a hard surface. Don't overcharge your device. battery recycling location.

power into a small device, Unplug it or remove the battery when it's fully charged.

> •Keep doorways, stairways, and windows clear. A fire involving a large device such as an e-bike can trap residents if left in an escape route like a doorway, stairwell, or window. Store e-bikes and electric scooters outdoors if possible.

•Recycle batteries responsibly. When it's time to dispose of the device or replace the battery, don't throw it in the trash or regular recycling bins. Physical damage in a compactor truck or transfer station is a common cause of lithium-ion battery fires. Instead, bring them to a safe

In 2023, the Department of Fire Services launched a data collection tool to help officials track the extent of fires, explosions, and other lithium-ion battery incidents. This investigative checklist is used by the State Police Fire & Explosion Investigation Unit, and local fire investigators are encouraged to use it as well. While previous reporting suggested about 20 lithium-ion battery fires per year, the new tool has identified about 90 so far this

properties.

The MCAC helps provide a voice for those communities and provide oversight to Massport, Toffler said.

Toffler highlighted the noise and air quality testing efforts that are underway in Winthrop and East Boston, as well as the MCAC's efforts to have Massport increase those efforts.

"We know we can't do everything, but we want to force Massport's hand and say, look, this is the data we are seeing, you guys should be collecting a lot more of it, and then we can talk about what the solutions to the problems are," said Toffler. "It's a major international

airport and it's not going to go away, but I do think there are some things that we can do once we get that cancer data or the data on heart disease ... and put together some really compelling stories about when the wind blows from the west."

Peter served as Winthrop's Superintendent of Schools in the 1980s and helped our school system navigate the difficult years in the immediate aftermath of the passage of Proposition 2 and 1/2, which had the ultimate result of severely limiting funding for Massachusetts school depart-

Although that would prove to be a tumultuous period both in Winthrop and across the state, Peter's steady hand and honest, straightforward approach guided our schools and community through those years.

The respect with which Peter was held by his fellow educators state-wide was evident by his selection as the Executive Director of the Massachusetts Superintendents of Schools Association in 1988.

Beyond his professional accomplishments, Peter was well-known and well-liked throughout our community as a member of the Winthrop Golf Club and for his support of Winthrop athletics. Peter was a regular at Viking sporting events during the playing days of his children Kristen, Courtney, and Paul, all of whom were outstanding athletes.

## A CORRECTION FOR OUR "MAHA MOMS" EDITORIAL

Two weeks ago in an editorial under the headline, "MAHA moms are right about toxic waste," we discussed a petition that some of the members of the MAHA movement had sent to President Donald Trump urging him to fire Lee Zeldin, his EPA administrator, because of Zeldin's recent directives that will make it easier for the production and use of harmful chemicals that threaten to contaminate our air, food, and water.

Moreover, Moms Clean Air Force has its own national campaign calling for the immediate resignation or firing of Zeldin — in fact, Moms Clean Air Force was the first national organization to take such action. But, as Moms Clean Air Force is totally independent of the MAHA petition; the timing was simply coincidental."

#### **CBS: A NEWSROOM** OR A PR FIRM?

Dear Editor,

I am disappointed by CBS News' spineless decision this past Sunday to pull its investigation into the "Inside CECOT" mega-prison in El Salvador. This was not a failure of journalism; it was a failure of nerve. And an irrefutable sign that "freedom of the press," as guaranteed by our First Amendment is clearly in danger.

The report, led by correspondent Sharyn Alfonsi, documented the "brutal and torturous" conditions facing migrants deported by the Trump administration to a facility described as a living hell. According to internal reports, the story was screened five times and fully cleared by both CBS legal and standards departments. When a news organization allows a government's refusal to comment to act as a veto over the truth, they have, as Alfonsi put it, handed the state a "kill switch" for any story deemed inconvenient.

the White House and rele-

vant agencies.

In Massachusetts, where

we pride ourselves on a history of speaking truth to power, this kind of corporate cowardice is particularly galling. CBS didn't pull the story because it was inaccurate; they pulled it because it was uncomfortable. By choosing political safety over revealing the truth about the suffering in CECOT, CBS has traded its "gold standard" reputation for political appeasement and a week of quiet. In America, every person on our soil has fundamental rights to fair legal treatment, including court hearings and processes, ensuring they aren't deprived of life, liberty, or property without due process of law, meaning even non-citizens facing deportation have rights to fair

hearings.

We deserve better from our public airwaves.
